

About

Metrochem is a customer-driven company with a focus on chemistry and innovation. At Metrochem, we understand our responsibility to deliver high quality pharmaceutical products which keeps us pushing ourselves to continuously improve and achieve our vision of providing reliable end to end pharmaceutical support in high growth and high impact therapeutic areas.

We began our humble journey in the year 2004, with a single unit Active Pharmaceutical Ingredient (API) manufacturing facility with 2 products in our pipeline. Quickly, we backward integrated to intermediates by starting our Intermediate manufacturing facility in 2005. Over the course of years, we started 2 more intermediate manufacturing facilities to fulfill our upstream needs.

Since our inception, we focused on generating value through vertical integration and continuous improvement of our infrastructure and manpower. This foresight about the importance of being vertically integrated allowed us to be always one step ahead of the competition. It helped us to better control the quality of ingredients that go into the final product, and have better command on the pricing along with an extreme efficiency in terms of deliveries. We have also focused on hiring the right, qualified teams to ensure the critical safety, and oversee the Production, QA, QC and Regulatory activities. Over the years, our ground-level efforts, coupled with our expertise in product development helped Metrochem clear several regulatory audits such as USFDA, PMDA, WHO-GMP and enabled us to become a strong, reliable and trustworthy partner to our clients globally.

At Metrochem, we never rest, we are always up for bigger and better challenges. To extend our impeccable service to the global markets and to meet the increasing demand across our portfolio, we have initiated the construction of a green-field 10 acre Vizag facility in 2012. It was built as a gateway to Metrochem's foray into the regulatory markets.

Our plants have an overall reactor volume of 3000KL with a range of 0.5KL to 15KL. The units are manned by over 3000 well-qualified and experienced Pharma professionals. In the financial year 2022-23 alone we have filed 19 USDMFs and are ranked #1 in the world, with this our total USDMF filings stand at 53.



Research & Development Focus

At Metrochem, we have a strong zeal for innovation and readiness for investments in Research and Development. This attitude has trickled down from the top, with our founder Dr. N.V.Rao being an expert in organic chemistry. We have extensively worked on and delivered new products across a wide variety of therapeutic segments and as a company we have built strong expertise in new product development.

With R&D efficiency as a core competency, Metrochem expanded its product portfolio from 2 to 300+ within a very short span and this number has been continuously increasing. To date, Metrochem has filed more than 102 patents and 17 patents have been successfully granted.

We have 3 stand-alone R&D centers located in Hyderabad with State-of-the-art analytical facilities and over 300 scientists. Our R&D focused culture allows us and our teams to work with passion and commitment, and therefore research out novel and economical routes efficiently.

We have invested \$5 million in 2019 alone to further upgrade our Analytical R&D. Annually, we invest >5% of our revenue in Research & Development activities. We also have a dedicated Formulation R&D center and a Process R&D lab that focuses on the application of flow chemistry and chemical engineering principles to improve our manufacturing capabilities, and achieve an overall operational excellence.
